**3.Pre-Qualifying Criteria (PQC):** In addition to other requirement of the tender the bidder is required to meet the following minimum Pre-Qualifying Criteria for becoming a qualified bidder:

### 10. Failure of Contractor:

10.1 If the contractor fails to complete the works, and as a result, the order/contract agreement is cancelled, the amount due to him, on account of work executed by him, if payable, shall be paid to him, only after due recoveries, as per the provision of contract, and only after alternative arrangement to complete the work have been made.

- 12.2.1 A detailed biological study of the study area [Core Zone and Buffer zone(10 KM radius of the periphery of the mine lease)] shall be carried out. Details of the flora and fauna, authenticated, separately for core and buffer zone should be furnished based on such primary field survey, clearly indicating the Schedule of the fauna present. In case of any scheduled-I fauna found in the study area, the necessary plan for their conservation should be prepared in consultation with State Forest and Wildlife Department and details furnished Necessary allocation of funds for implementing the same should be made as part of the project cost.
