(A) TECHNICAL :-

1. The bidder should be a company incorporated under the Companies Act, 1956/2013 or ownership/ partnership/firm/LLP under the LLP Act, 2008

2. The bidder should have mined at least 05 lac (Five Lac) metric ton of the following minerals during the preceding 5 years anywhere in India:-

Bauxite ,Iron ore, Coal, Lime Stone, Dolomite, Manganese, Rock Phosphate.

or

The bidder should have its own plant for the manufacturing of alumina/aluminium.

or

The bidder should have signed an MoU for putting plant in any State for the manufacturing of alumina/ aluminium.

or

The bidder should have traded at least 1 lac (One Lac) metric ton of any of the following minerals during the preceding 5 years anywhere in India:-

Bauxite ,Iron ore, Coal, Lime Stone, Dolomite, Manganese, Rock Phosphate

(B) FINANCIAL :-

1. The average annual turnover of the bidder should not be less than 5 crore(Five Crore) in the last 03(three) financial years.

2. The bidder should not have a negative net worth in any of the last 03 (three) financial years.
