**(A) TECHNICAL :-**

1. The bidder should be a company incorporated under the Companies Act, 1956/2013 or ownership/ partnership firm registered under Indian Partnership Act, 1932/LLP under the LLP Act, 2008
2. The bidder should have mined at least 05 lac (Five Lac) metric ton of any notified mineral (Schedule IV mineral) during the preceding 5 years anywhere in India.
3. The bidder should have its own plant for the manufacturing of alumina/aluminum /Calcinations.

**(B) FINANCIAL :-**

1. The average annual turnover of the bidder should not be less than 5 crore(Five Crore) in the last 03(three) financial years.
2. The bidder should not have a negative net worth in any of the last 03 (three) financial years.
